- Do not require the use of physical or chemical restraint

Prospective applicants are interviewed to determine whether their needs can be adequately met by our facility. Upon admission of a resident, management enters into a written agreement with the resident or a representative. The agreement will include a statement of all fees, refund policy, consent to release medical information, provisions for continuous assessment, and policies on transfers and discharges, etc. Each applicant will be considered on an individual case basis.
